

Acronyms/Definitions

Certified Treatment Bed - A licensed facility providing short-term, medically necessary withdrawal management and stabilization, staffed with medical professionals, offering 24/7 monitoring, restrictive rules, and insurance acceptance.

Certified Recovery Housing - A peer-run or staff-managed home offering long-term support for individuals in recovery, where residents pay rent, receive assistance, and have the freedom to work and attend meetings, without on-site clinical services.

Medication Assisted Treatment/Medications for Opioid Use Disorders

(MAT/MOUD) - refers to the U.S. Food and Drug Administration approved medications used to treat opioid use disorder.

Substance Prevalence in Overdose Fatalities - These deaths were determined to be caused by drug poisoning. They are shown by the county of occurrence, and are not based on the residence of the individual. The Other Drug category includes Xylazine, Antidepressants, or other non-opioid related drugs. The Other Opioid category includes Buprenorphine, Methadone, Carfentanil, or other synthetic opioids that are not Fentanyl or Heroin.

Substance Use Disorder (SUD) - the recurrent use of alcohol or drugs causing clinically significant impairment, including health problems, disability, and failure to meet major responsibilities at work, school, or home.
